1. Health Guarantee Overview

The Breeder guarantees that the above-described puppy is in good health at the time of sale and free of life-threatening congenital or hereditary conditions for a period of **one (1) year** from the date of birth.

2. Initial Vet Exam Requirement

- The Buyer agrees to have the puppy examined by a licensed veterinarian within 7 business days of receiving the puppy.
- If a serious health issue is found at that initial exam, the Buyer must notify the Breeder within 24 hours and provide written documentation from the veterinarian.
- The Breeder reserves the right to get a second opinion from a veterinarian of their choice.

3. Covered Conditions

This guarantee covers genetic or hereditary conditions that severely affect the puppy's quality of life, such as:

- Heart defects
- Liver shunt
- Kidney defects
- Severe hip or elbow dysplasia (confirmed by OFA or PennHIP)
- Other major organ dysfunction diagnosed as congenital

This guarantee does not cover:

- Minor or treatable conditions such as parasites, coccidia, giardia, or kennel cough
- Conditions caused by injury, neglect, accidents, or improper care
- Reactions to vaccines or preventatives
- Normal breed traits like retained testicles, underbites, or cherry eye

4. Remedy

If a covered genetic condition is diagnosed within the first year:

- The Buyer may choose a replacement puppy of equal value from the next available litter (no cash refunds).
- The affected puppy must be spayed/neutered and remain with the Buyer unless both parties agree to a return.
- Proof of diagnosis from a licensed veterinarian must be provided. The Breeder may request a second opinion.

5. Buyer Responsibilities

To maintain this guarantee, the Buyer agrees to:

- Provide regular veterinary care and keep all vaccines and deworming up to date
- Feed a high-quality, appropriate diet
- Not allow the puppy to be over-exercised during growth (no forced running or jumping)
- Maintain a clean, safe environment
- Not breed the puppy—**this guarantee is void if the puppy is bred!**

6. Limitation of Liability

The Breeder's liability is limited to the original purchase price of the puppy. The Breeder is not responsible for any vet bills, emotional distress, transportation, or other costs incurred by the Buyer.

7. Agreement
